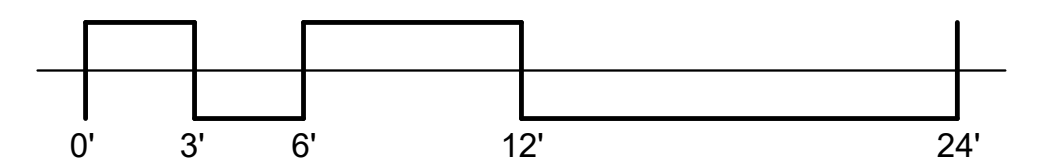
KEY PLAN

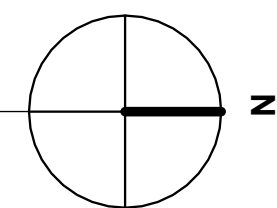
