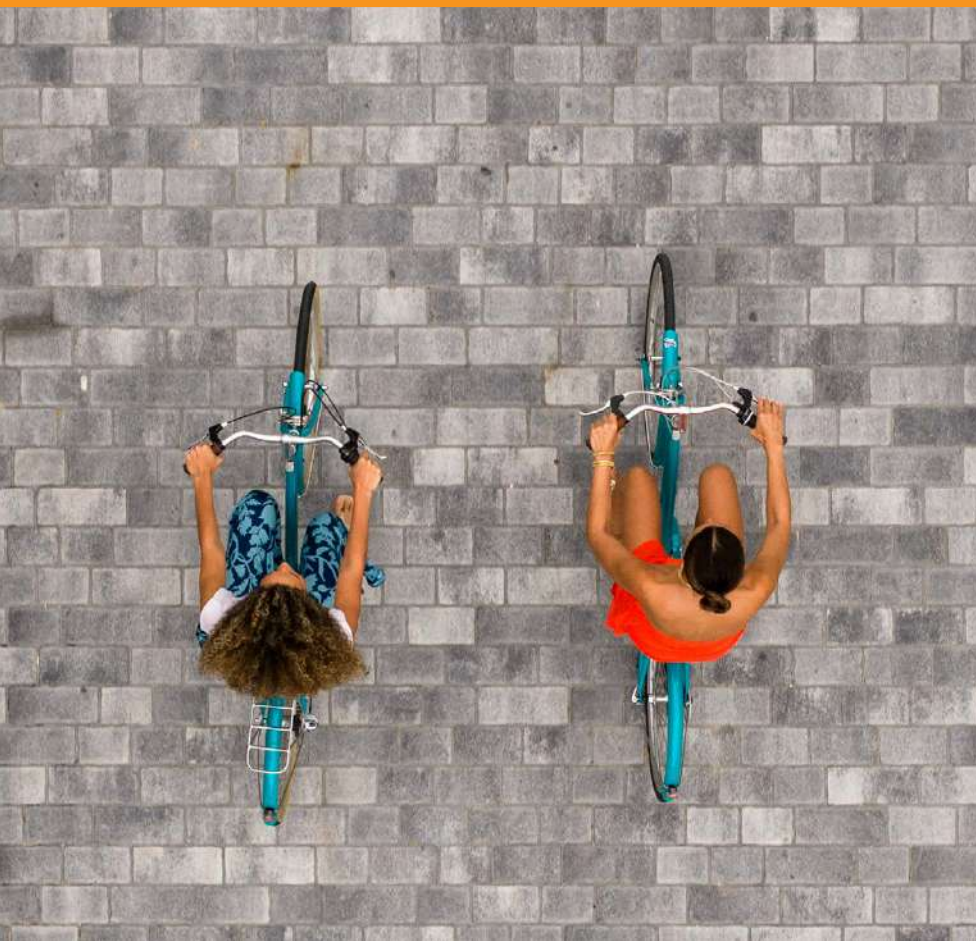

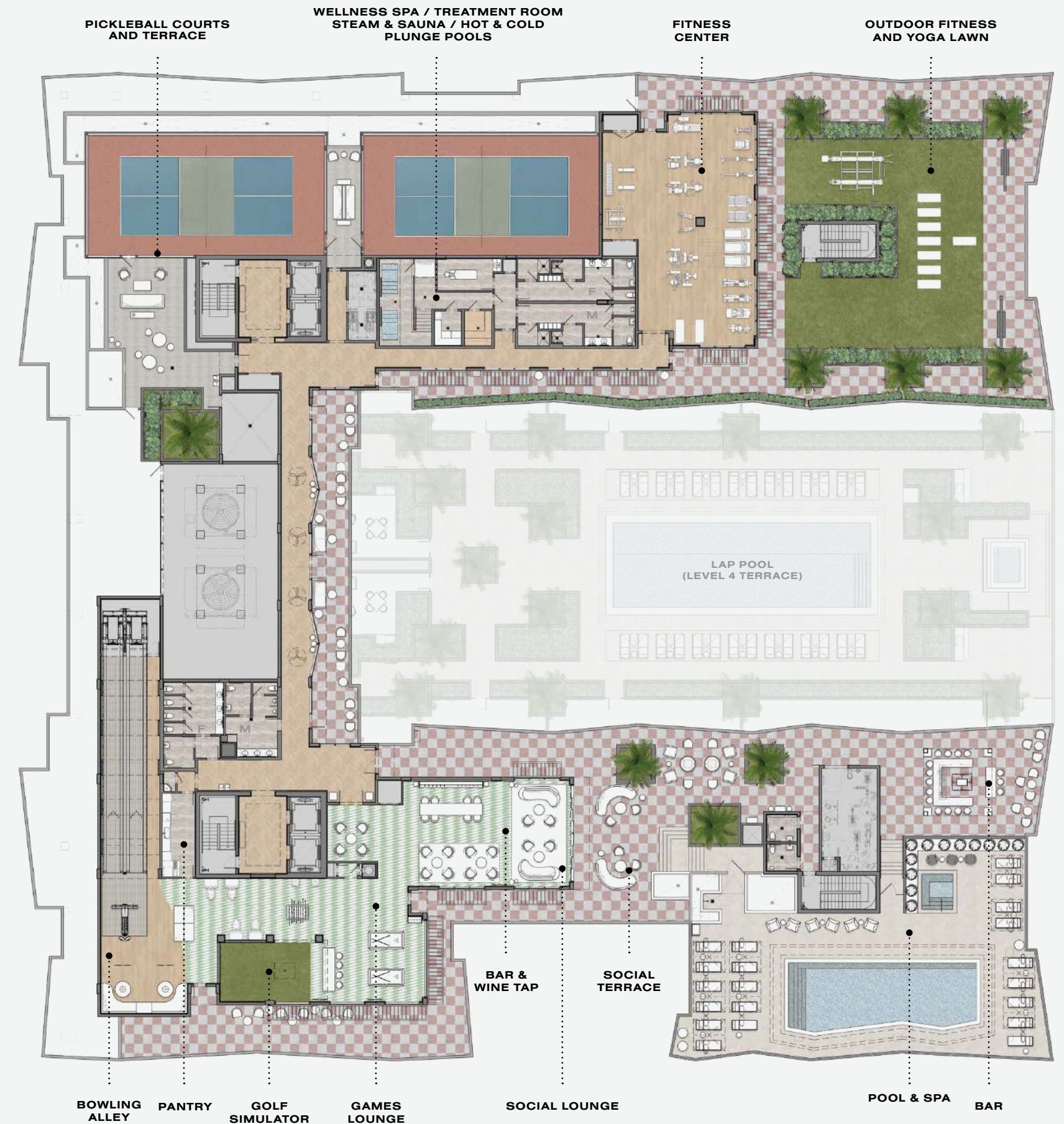
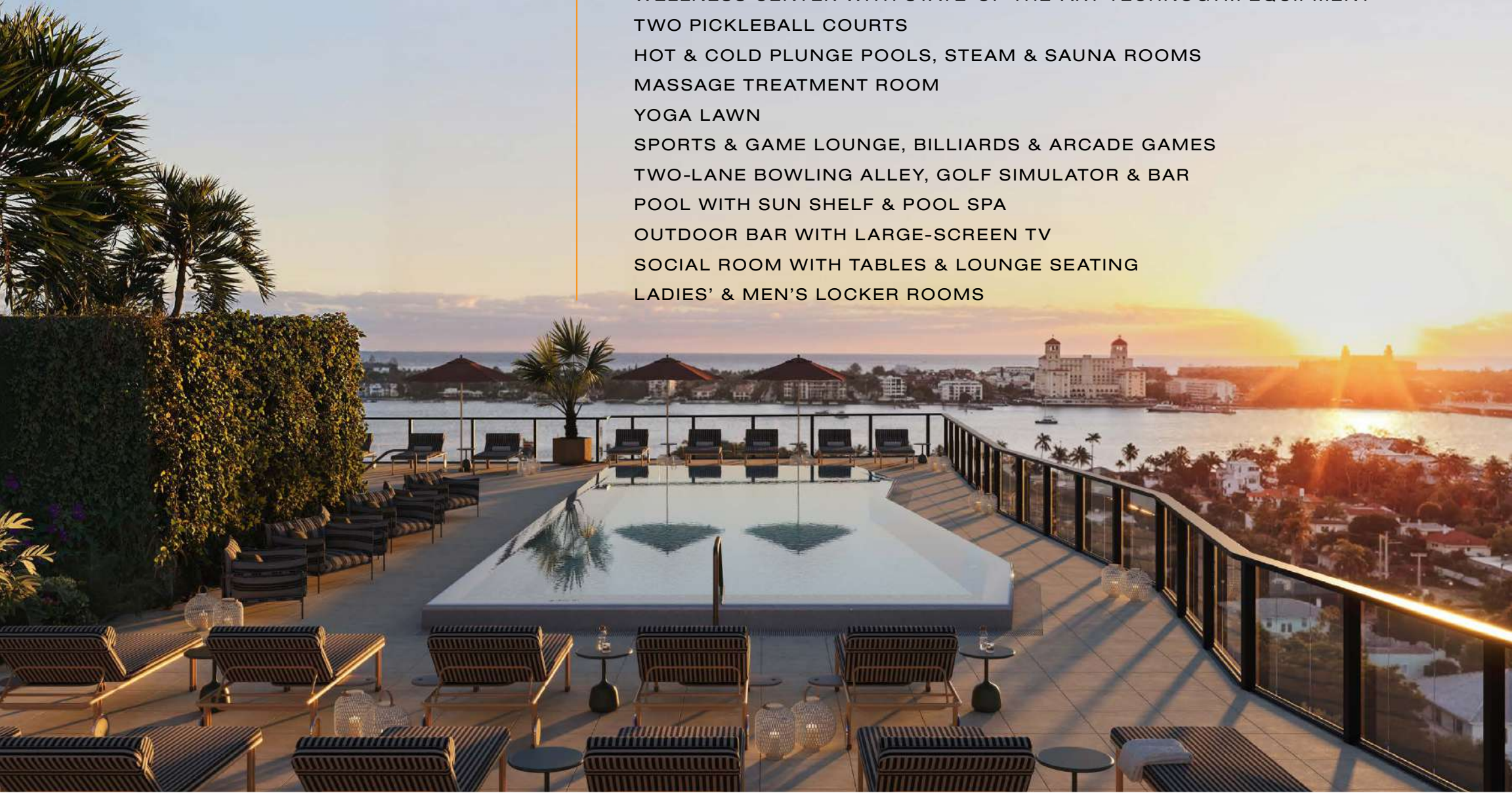


Residents of Nora House will enjoy an expansive suite of indoor and outdoor amenities, including a landscaped courtyard deck with a lap pool and separate pool spa, men's and women's pool bathrooms, and six guest suites for visiting friends and family.

At the rooftop level, amenities expand to include two pickleball courts, a state-of-the-art fitness center, yoga lawn and a comprehensive spa featuring steam rooms, a sauna, massage rooms, and hot and cold plunge pools with dedicated men's and women's facilities. Additional social offerings include a sport and game lounge with billiards, arcade games, and bar; a two-lane bowling alley; golf simulator; and a social room with catering capabilities. Outdoor rooftop features include a pool with a sun shelf and spa, an outdoor bar and social terrace, a fire pit with seating areas, and an elevated landscaped fitness and yoga lawn designed for relaxation and gathering.

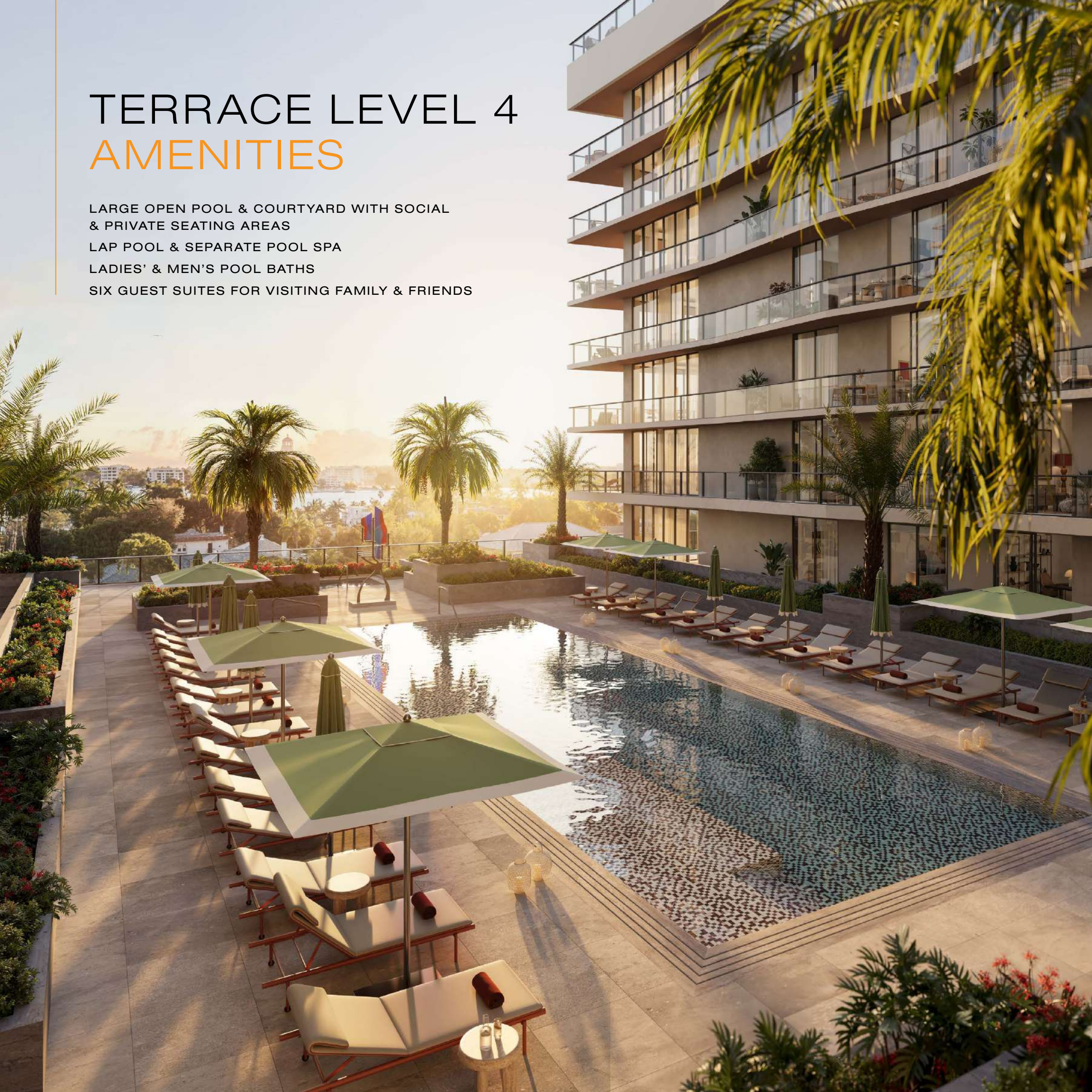
